## 1 Procedural History

- a) The Dispute was filed with the South African Institute of Intellectual Property Law (the "SAIIPL") on **17 October 2016**. On **18 October 2016** the SAIIPL transmitted by email to the ZA Central Registry (ZACR) a request for the registry to suspend the domain name(s) at issue, and on **18 October 2016** ZACR confirmed that the domain name had indeed been suspended. The SAIIPL verified that the Dispute satisfied the formal requirements of the .ZA Alternate Dispute Resolution Regulations (the "Regulations"), and the SAIIPL's Supplementary Procedure.
- b) In accordance with the Regulations, the SAIIPL formally notified the Registrant of the commencement of the Dispute on **19 October 2016**. In accordance with the Regulations the due date for the Registrant's Response was **16 November 2016**. The Registrant did not submit any response, and accordingly, the SAIIPL notified the Registrant of its default on **17 November 2016**.
- c) The SAIIPL appointed Victor Williams as the Adjudicator in this matter on 28 November 2016. The Adjudicator has submitted the Statement of Acceptance and Declaration of Impartiality and Independence, as required by the SAIIPL to ensure compliance with the Regulations and Supplementary Procedure.

#### 2 Factual Background

- 2.1 The Complainant is a JSE Listed company. The Complainant established its Sunday newspaper SUNDAY TIMES in February 1906, and distributed same since then throughout the Republic of South Africa and neighbouring countries.
- 2.2 SUNDAY TIMES is the biggest selling Sunday newspaper in South Africa, and is distributed online and through many retail outlets.

- 2.5 The domain name sundaytimes.co.za was registered on 10 August 1998.
- 2.6 The disputed domain name was registered on 19 December 2013.

# 3 Parties' Contentions

#### 3.1 **Complainant**

- The disputed domain name is identical or similar to a mark in which the Complainant has rights, both in respect of registered trademarks and in terms of the common law.
- b) The trademarks of the Complainant have due to its extensive marketing and exposure become a well-known brand in South Africa.
- c) The purpose of the disputed domain name is to generate hits, and the disputed domain name is likely to create deception and/or confusion in the minds of members of the general public.
- d) The Disputed domain name incorporates the words SUNDAY TIMES wholly, which words is the dominant and memorable part of the domain name.
- e) The Registrant has been a Defendant in several domain name complaints, mostly filed by big brand owners.

# 3.2 Registrant

a) The Registrant is in default, and has filed no papers.



#### 4 Discussion and Findings

- a) 1. The Complainant has extensive rights in the words SUNDAY TIMES, as a result of the protection afforded by the Trade Marks Act, 194 of 1993, and also in terms of the common law.
  - 2. SUNDAY TIMES is a well known brand in South Africa.
  - 3. The Complainant has domain name rights in sundaytimes.co.za, the registration of which predates the registration of the disputed domain name.
  - 4. The disputed domain name is similar to the domain names of the Complainant, and the registered trademarks of the Complainant.
  - 5. The addition of the word LIVE in the disputed domain name is insufficient to distinguish the domain name, and is likely to cause confusion and/or deception in the minds of the members of the general public. This addition in fact in the media and publishing industry serves only to bring the disputed domain name closer to the trademarks and domain names of the Complainant.

# 4.1 **Complainant's Rights**

4.1.1 The rights of the Complainant in the words SUNDAY TIMES have been fully set out and discussed above.

# 4.2 Abusive Registration

- 4.2.1 In the light of the proven facts, the disputed domain name is an abusive registration, as
- 4.2.2 It was registered at a time and in a manner that took unfair advantage of the registered and common law rights of the Complainant, and
- 4.2.3 Is likely to cause confusion and/or deception in the minds of the members of the general public, and



4.2.4 It was registered to prevent the Complainant from registering a similar domain name, and to prevent the Complainant from exercising its registered and common law rights.

## 5. Decision

5.1 For all the foregoing reasons, in accordance with Regulation 9, the Adjudicator orders that the domain name sundaytimeslive.co.za be transferred to the Complainant.
