



The adjudicator reviewed the website at www.f1group.co.za, and noted that some changes have been made to the website, namely the removal of images of formula 1 cars. It is the adjudicator's view that the changes do not save the Registrant, as the screenshots forming part of the complaint clearly show that the possibility exists, and indeed it has happened in the past, that the Registrant can ride on the Complainant's reputation to promote services rendered through the site linked to this domain name.

8. Decision

For all the foregoing reasons, in accordance with Regulation 9, the Adjudicator orders that the domain name, f1group.co.za, be transferred to the Complainant
